### **Vendor Information**

**When:** Saturday September 18, 2021, 12-5p.m. Set-up for vendors 9-11a.m.

**Where:** Corner of Rt. 6 and Fifth Street in Wyalusing. This was the former location of the Wyalusing Elementary School and is on property owned by Tuscarora Wayne Insurance Company.

Outdoors, rain or shine.

**Fees:** \$50 for a 10'x10' space and two tasting ticket admissions to the wine festival. Need more space? Contact us. You are responsible for bringing your own tent, tables, etc.

#### **Information you need to provide:**

- **PA Sales Tax License Number:** Under the Pennsylvania Tax Reform Code of 1971, we cannot permit anyone to “display for sale or sell taxable tangible personal property or services” unless the person or business has a valid Pennsylvania Sales, Use and Hotel Occupancy Tax License and the person or business provides its name, address and Pennsylvania Sale, Use and Hotel Occupancy Tax License number to us. If you do not have a valid PA Sales, Use and Hotel Occupancy Tax license, you can apply online at <https://www.pa100.state.pa.us> or you can call the PA Department of Revenue, 717-787-1064 for more information.
- **Proof of Insurance** At the request of the property owner, food vendors will need to provide a certificate of insurance listing the Wyalusing Valley Wine Festival (PO Box 322, Wyalusing, PA 18853) and Tuscarora Wayne Insurance Company (PO Box 7, Wyalusing, PA 18853) as additional insured. All other vendors just need to provide proof of insurance.

The Lions, the Wyalusing Valley Museum, and Tuscarora Wayne are not responsible for items damaged during this event.

If you are a vendor for a company, we will only accept one vendor per company on a first-come-first-served basis.

**Registration will be handled differently this year:** Because we may need to limit the number of people at the event, if you are interested in participating, please mail or email your registration form to us right away but don't send in your registration fee just yet. Once we know how many people we can have on site, we will contact vendors to let them know if they have been accepted or not and we will invoice you for the registration fee at that time.
